

**BAC RESOLUTION DECLARING A FAILURE OF BIDDING FOR THE
ENGAGEMENT OF A TECHNICAL CONSULTANT FOR THE PREPARATION
OF BUSINESS PLANS UNDER RAPID GROWTH PROJECT**

WHEREAS, the Department of Trade & Industry-XI had posted Request for Expression of Interest for the Engagement of a Technical Consultant for the Preparation of Business Plans under RAPID Growth Project on November 14, 2020 at the Philippine Government Electronic Procurement System (PhilGEPS) website, official website of DTI and the bulletin board on the premise of the DTI-XI Office, Mintrade Bldg., Monteverde corner Sales St., Davao City;

WHEREAS, in response to the said advertisement, two (2) consultants submitted applications for eligibility namely: 1. Ateneo de Davao Univeristy – Institute for Socio-Economic Development Initiatives (ISED I) and 2) Robert C. Bastillo and Team Consultants;

WHEREAS, on November 23, 2020, 9:00 am, the DTI-XI Bids and Awards Committee (BAC) conducted the Eligibility Checking and Shortlisting by examining each bidder's eligibility documents using non-discretionary "Pass/Fail" criterion as stated in the Request for Expression of Interest, and shall be determined as either "eligible" or "ineligible and evaluation through shortlisting criteria and rating system;

WHEREAS, during the eligibility checking, both Ateneo de Davao Univeristy – Institute for Socio-Economic Development Initiatives (ISED I) and Robert C. Bastillo and Team Consultants were declared ineligible due to incomplete submission of eligibility requirements;

WHEREAS, Section 35.1 of the R.A. No. 9184 provides in pertinent part:

"Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

xxx

b.) All prospective bidders are declared ineligible;

xxx"

WHEREAS, pursuant to Section 35.2 of the 2016 IRR of R.A. No. 9184, in order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates;

NOW THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to **DECLARE A FAILURE OF BIDDING FOR THE ENGAGEMENT OF A TECHNICAL CONSULTANT FOR THE PREPARATION OF BUSINESS PLANS UNDER RAPID GROWTH PROJECT**.
