

BAC RESOLUTION DECLARING SRRB AND RECOMMENDING APPROVAL

RESOLUTION NO. 02
Series of 2020

WHEREAS, the Department of Trade & Industry-XI advertised continuously for 8 days the Request for Expression of Interest for the Procurement of Consulting Services In Preparation of Regional Strategic Investment Plan (RSIP) For Coconut & PFN-Banana Industry in the PhilGEPS and at the conspicuous places of DTI-XI;

WHEREAS, the procurement of said services shall be undertaken through competitive bidding using Quality Based Evaluation (QBE) procedure with 70% minimum score to be shortlisted;

WHEREAS, in response to the said advertisement, two bidders submitted their eligibility documents before the deadline of submission on July 30, 2020 at 8:00 AM:

1. Foundation for Rural Enterprise and Ecology Development of Mindanao (FREEDOM), Inc.;
2. Infoshare Management Systems;

WHEREAS, on July 30, 2020, only Foundation for Rural Enterprise and Ecology Development of Mindanao (FREEDOM), Inc. was declared eligible and shortlisted;

WHEREAS, Foundation for Rural Enterprise and Ecology Development of Mindanao (FREEDOM), Inc. purchased bid documents and submitted their Technical and Financial Proposal before the deadline on August 17, 2020 at 8:00 AM;

WHEREAS, upon detailed evaluation of the technical proposals using Collegial Evaluation Process conducted on August 20, 2020, Foundation for Rural Enterprise and Ecology Development of Mindanao (FREEDOM), Inc. was determined to be single rated and responsive bid with a score of 73% based on the set evaluation criteria requiring a minimum score of 70% as follows;

Criteria for Technical Proposal	Bidder: Foundation for Rural Enterprise and Ecology Development of Mindanao (FREEDOM), Inc.
Quality of Personnel to be assigned (15%)	13%
Experience and Capability of the Consultant (40%)	15%
Plan of Approach and Methodology (45%)	45%
Total (100%)	73%


