RESPONSE # 2

A representative of the signatory/signatories (affiant/s) may go to the Philippine Consulate for the notarization of documents provided he or she has an authorization letter signed by the signatory/signatories (affiants). Copies of signed passports of the signatory/ signatories (affiant/s) and the representative must both be attached to the authorization letter.

Do we need to bring other pertinent documents like passport, trade license etc.?

RESPONSE # 3

All documents that need to be notarized at the Philippine Consulate must be attached with signed copies of passports of the signatory/ signatories (affiant/s). The signature in both the documents for notarization and in the attached passport/s should be identical.
