Once registered, bidders will receive a QR code via email, which bidders will have to print to show the security personnel and Consular Officer upon arrival at the PCG. NO QR CODE, NO ENTRY. The appointment schedule is also non-transferable. This is for strict compliance as precaution related to the pandemic.

BIDDER'S INQUIRY?	RESPONSE
Query No.1 - Is the duration of the contract only up to 31st December 2021? Is this correct?	Yes, that is correct. FMMC contract will end on December 31, 2021.
Query No. 2 - Are we allowed to bid thru our FMMC working with us, and use their license and registration name? Are we allowed to pre-register them? OR they can directly participate in the bid?	The bid invitation is open to all qualified companies. There is no need for pre-registration. FMMC working with you may bid directly with us. You may also enter an agreement in order to bid on their behalf. Both are acceptable. However, if it is the latter, an agreement with the scope of work clearly stipulated must be attached in the submission of the bid documents.
Query No. 3 - Are the files on the link the complete bidding documents, or more documents need to be collected from your office in Business Bay?	The files in the link provided (11 documents) is the complete set of documents. There is no need to collect in the PTIC office if you are able to access the complete files as listed.

Query No. 4 – May we request a schedule for a site visit of the Republic of the Philippines Pavilion? We can access the Expo Site but not your Pavilion.

The Republic of the Philippines Pavilion is open for ocular site visit from 8:30 AM to 11:30 AM on 20-22 April 2021.
