This shall undergo the Overseas Procurement procedure as specified in the **Resolution No. 28- 2017** (Approving Guidelines for the Procurement of Goods and Services, Infrastructure Projects, and Consulting Services to be procured and performed overseas) and will undergo an evaluation of the submitted work portfolio to be conducted by the Authorized Representative in Dubai for Philippine Bids and Awards Committee;
6. Bidding is open to all interested bidders registered in U.A.E. subject to the conditions for eligibility as contained in the attached Terms of Reference, Annexes and Bidding Documents.
7. The contract duration will be for a period: **November 2020 to July 2021**.

The *Department of Trade and Industry (DTI)*, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
