

MEMORANDUM CIRCULAR NO. 21-15

Series of 2021

SUBJECT ADDITIONAL BUSINESS ESTABLISHMENTS, PERSONS OR

ACTIVITIES ALLOWED TO OPERATE IN AREAS PLACED

**UNDER MECQ** 

WHEREAS, to restore more jobs in labor-intensive industries, ease the economic burden of displaced workers and address the growing number of joblessness, poverty, and hunger incidence, without compromising the safety and fight against COVID-19, and upon consultation with all stakeholders, IATF Resolution No. 113 dated 29 April 2021 allowed "fflood preparation establishments such as commissaries, restaurants, and eateries [to] resume their indoor dine-in services in areas under Modified Enhanced Community Quarantine at an initial venue or seating capacity of ten percent (10%)," while "[b]eauty salons, beauty parlors, barbershops, and nail spas may resume operations at an initial venue or seating capacity of thirty percent (30%);" and that said establishments may further operate beyond the limitation prescribed, provided that they comply with the DOLE-DOH-DILG-DOT-DTI Joint Memorandum Circular (JMC) No. 21-01, Series of 2021 or the Implementing Guidelines of the Safety Seal Certification Program;

WHEREFORE, foregoing premises considered, the following guidelines are hereby prescribed to allow additional business establishments, persons or activities to operate, work or be undertaken in areas placed under Modified Enhanced Community Quarantine (MECQ) --

SEC. 1. Additional Business Establishments, Persons or Activities Allowed to Operate On-site under MECQ -- Subject to compliance with the minimum public health and safety standards and protocols and the relevant issuances, such as DOH Administrative Order No. 2020-0015, Series of 2020 dated 27 April 2020, DTI-Department of Labor and Employment (DOLE) Joint Memorandum Circular No. 20-04-A, Series of 2020 on Workplace Prevention and Control of COVID-19 dated 15 August 2020, applicable sector-relevant guidelines, and other pertinent issuances, the following business establishments, persons, or activities shall be allowed to operate on-site in areas placed under MECQ beginning 01 May 2021 --

- a. Indoor dine-in services of food preparation establishments, such as commissaries, restaurants, and eateries, at an initial venue or seating capacity of 10% (Annex "B"); and
- b. Beauty salons, beauty parlors, barbershops, and nail spas, at an initial venue or seating capacity of 30%, provided that they shall only provide services that can accommodate the wearing of face masks at all times by the patrons/clients and service providers (Annex "C").

Attached as Annex "A" and made an integral part hereof is the revised list of business establishments, persons or activities allowed to operate, work or be undertaken under the applicable community quarantines. CERTIFIED TRUE PHOTOCOPY

- **SEC 2. Certification under Safety Seal Certification Program.** The initial capacity prescribed in Section 1 may be increased upon the business establishment's certification under the Safety Seal Certification Program under JMC No. 21-01, Series 2021.
- **SEC 3. Compliance Monitoring and Complaints Handling.** The DTI, through the FTEB and Regional or Provincial Offices, shall continue its strict compliance monitoring through its post-audit mechanism. Inspection by the DOLE, DOH, and the LGU's Health Office may also be conducted at any time.

Violations of this Circular shall be subject to corresponding penalties under relevant rules and guidelines including the temporary suspension of business operations as may be necessary and applicable.

All feedback and complaints from the general public may be coursed through the DTI Consumer Care Hotline 1-384.

- **SEC. 4. Repealing Clause.** Provisions of relevant Memorandum Circulars that are inconsistent with this Circular are hereby superseded or amended accordingly.
- **SEC. 5. Effectivity.** Given the presence of a public health emergency, this Circular shall immediately take effect upon its publication and filing with the University of the Philippines Law Center.

## ANNEX "B": MANDATORY HEALTH AND SAFETY PROTOCOLS FOR INDOOR DINE-IN SERVICES OF FOOD PREPARATION ESTABLISHMENTS, SUCH AS COMMISSARIES, RESTAURANTS, AND EATERIES

- 1. Face masks and face shields shall be worn at all times within the premises of the establishment.
- 2. Employees and customers are required to scan the StaySafe PH QR Code posted at the entrance for contact tracing purposes
  - a. In the absence of smartphones, they shall fill out an employee health declaration form or customer contact tracing form upon entry.
- 3. Thermal scanning of all employees, suppliers, customers prior to entry -- persons with a temperature higher than 37.5 degrees centigrade shall not be allowed entry.
- 4. No employee with COVID-19 symptoms or with exposure to COVID-19 patients shall be allowed to report for work.
- Rubbing alcohol/sanitizers, which can be easily sprayed on the hands of employees, suppliers and customers prior to entry, must be provided. Hands of workers and customers must be sanitized at regular intervals.
- 6. Physical distancing measures shall be strictly observed in all parts of the establishment, including the queuing areas, cashier counter, beverage bar, kitchen, and back areas.
- 7. Chairs and tables must be rearranged to conform with the allowed on-site capacity.
- 8. Ventilation of establishments shall be in accordance with Department Order No. 224, series of 2021, of the Department of Labor and Employment (DOLE), otherwise known as the Guidelines on Ventilation for Workplaces and Public Transport to Prevent and Control the Spread of COVID-19.
- 9. Buffet service shall be allowed only when -
  - a. Food servers are provided; and
  - b. All food trays are with food covers.
- 10. Ambient music in restaurants and fastfood chains shall be kept to a minimum to discourage loud talking, which increases the likelihood of droplet transmission.
- 11. Equipment in kitchen, food preparation, and serving areas shall be frequently sanitized.
- 12. Restrooms shall be properly sanitized and free of accumulation of trash.
- 13. Play areas shall be closed.

## ANNEX "C": MANDATORY HEALTH AND SAFETY PROTOCOLS FOR BEAUTY SALONS, BEAUTY PARLORS, BARBERSHOPS, AND NAIL SPAS

- 1. Services shall be limited to those that can accommodate the wearing of face masks at all times by the patrons/clients and service providers.
- 2. Employees, suppliers, and customers are required to scan the StaySafe PH QR Code posted at the entrance for contact tracing purposes
  - a. In the absence of smartphones, they shall fill out an employee health declaration form or customer contact tracing form upon entry.
- 3. Thermal scanning on all employees, suppliers, and customers prior to entry -- persons with a temperature higher than 37.5 degrees centigrade shall not be allowed entry.
- 4. No employee with COVID-19 symptoms or exposure to COVID-19 patients shall be allowed to report for work.
- 5. Provision for rubbing alcohol/sanitizer, which can be easily sprayed on the hands of employees, suppliers, and customers prior to entry, and regular interval of sanitation of hands of employees and customers.
- 6. Physical distancing measures shall be observed in all parts of the establishment, including the reception, cashier, styling area, shampoo area, and nail care area.
- 7. Chairs must be arranged with at least one (1) meter distance on all sides, while complying with the maximum allowable operational capacity.
- 8. Ventilation of establishments shall be in accordance with Department Order No. 224, series of 2021, of the Department of Labor and Employment (DOLE), otherwise known as the Guidelines on Ventilation for Workplaces and Public Transport to Prevent and Control the Spread of COVID-19.
- 9. Restrooms shall be properly sanitized and free of accumulation of trash.
- 10. Equipment, tools, and workstation shall be sterilized before and after each service.
- 11. Companions shall not be allowed entry, unless absolutely necessary.
