

ADVISORY NO. 21-09 Series of 2021

ON THE INCREASE IN ON-SITE OPERATIONAL CAPACITY OF CERTAIN BUSINESS ESTABLISHMENTS AND ACTIVITIES UNDER GENERAL COMMUNITY QUARANTINE WITH HEIGHTENED RESTRICTIONS

Pursuant to IATF Resolution No. 118-A, Series of 2021, and subject to the minimum public health and safety standards and applicable sector-relevant protocols, the prescribed on-site operational or venue capacity of the following business establishments and/or activities in the *provinces of Bulacan, Cavite, Laguna, and Rizal together with the highly urbanized cities of the National Capital Region and the municipality of Pateros* ("NCR Plus") under General Community Quarantine with heightened restrictions from **01 June to 15 June 2021** shall be --

- a. Food preparation establishments such as commissaries, restaurants, and eateries may operate with their indoor dine-in services at the venue or seating capacity of thirty percent (30%), and with their *al fresco* or outdoor dine-in services at fifty percent (50%);
- b. Personal care services, such as beauty salons, beauty parlors, barbershops, and nail spas, may operate up to **forty percent (40%)** venue or seating capacity, *provided* that these establishments shall only provide services that can accommodate the wearing of face masks at all times by patrons/clients and service providers; and
- c. Meetings, Incentives, Conventions, and Exhibitions (MICE) events in eligible venue establishments shall be allowed to resume up to thirty percent (30%) of its venue capacity, while social events in the same establishments shall be allowed up to ten percent (10%) of the venue capacity, subject to DTI and Department of Tourism (DOT) guidelines.

Attached as Annex "A" is the updated list of business establishments and their prescribed onsite operational or venue capacity.

Moreover, under the Safety Seal Certification Program, business establishments awarded Safety Seal Certifications pursuant to DOLE-DOH-DILG-DOT-DTI Joint Memorandum Circular No. 21-01, Series of 2021 shall be allowed to operate at an additional 10 percentage points beyond the prescribed on-site operational or venue capacity, whichever is applicable. This privilege shall also apply to all business establishments under other community quarantine classifications.

Strict monitoring of compliance with minimum public health and safety standards and protocols under DOH Administrative Order No. 2020-0015, Series of 2020, DTI-DOLE JMC No. 2020-04-A, Series of 2020, DOLE Department Order No. 224-21, Series of 2021, and applicable sector-relevant guidelines, shall continue to be enforced.

Be guided accordingly.
