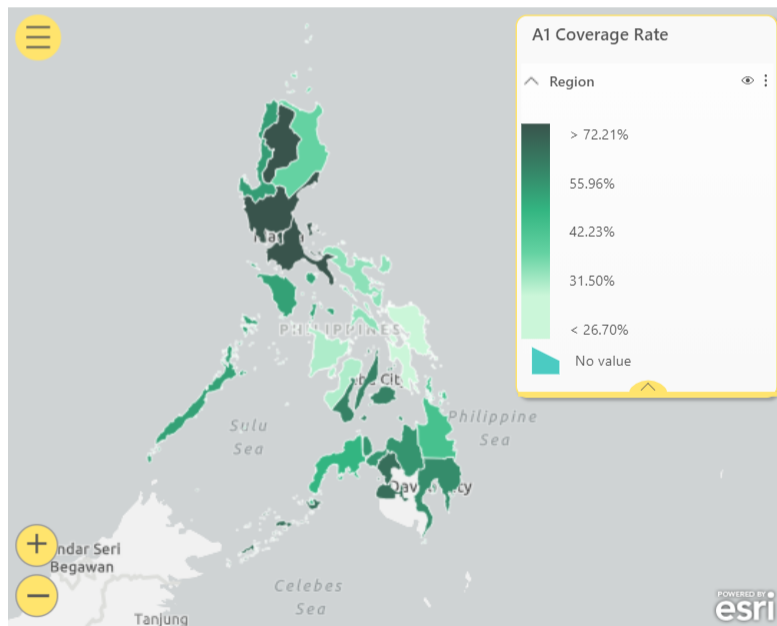

The road, rail, maritime, and aviation sectors of public transportation shall be **allowed to operate** at such capacity and protocols in accordance with guidelines issued by the DOTr. 

The use of active transportation such as biking is encouraged.



SUSPENDED ECQ & MECQ AREAS

Face-to-face or in-person classes

The education sector shall operate in accordance with the guidelines of the CHED for higher education, TESDA for technical vocational education and training, DepEd for basic education.

GATHERINGS

ECQ

PROHIBITED

- Gatherings outside of residences
- Gatherings at residences with any person outside of one's immediate household

ALLOWED

- Essential for the provision of health services, government services, or humanitarian activities
- Pastors, priests, rabbis, imams, religious ministers, assistants (religious services performed through online, necrological services, wakes, inurnment, and funerals, and they shall be allowed to move)
- Allowed to move: immediate family members to attend the wake or interment of the deceased

MECQ

PROHIBITED

- Gatherings outside of residences
- Gatherings at residences with any person outside of one's immediate household

ALLOWED

- **Religious gatherings – 10% venue capacity**
- **LGU may increase up to 30%**
- Allowed: gathering for necrological services, wakes, inurnment, funerals
- Allowed to move: immediate family members to attend the wake or interment of the deceased

All establishments, persons, or activities **not permitted** to operate, work, or be undertaken during ECQ **shall be allowed to operate at 50% on-site capacity**, while encouraging work-from-home and other flexible work arrangements, where applicable.

Notwithstanding the foregoing, and without prejudice to the authority of DTI to issue a **negative list of industries which shall remain prohibited even in areas under MECQ**.
