### Employers and workers involved in the manufacturing of the following:

  - Medicines and Vitamins
  - Medical Products such as PPEs, Masks, Gloves
  - Pet Food
- Feeds, Fertilizers and Pesticides
- Electrical and Machinery Equipment
- Wood Products and Furniture
- Nonmetallic Products
- Textiles/Wearing Apparels
- Tobacco Products
- Paper and Paper Products

- Those traveling for medical or humanitarian reasons
- Pastors, Priests and Imams or such other religious ministers whose movement shall be related to the conduct of necrology or funeral rites
- Those engaged in limited outdoor exercise (e.g., outdoor walk, jog/run, bike)
- Those involved in limited contact sports (e.g., golf, tennis)
- Individuals preferably 21 to 59 years old availing essential goods and services within their respective localities

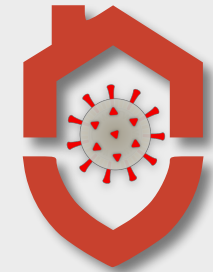
