## Certificate of Conditional Release (CCR) / Statement of Confirmation (SOC) Documentary Requirements

- 1. Packing List.
- 2. Commercial Invoice.
- 3. Bill of Lading
- 4. Summary of the production batch, lot, or serial numbers.
- 5. For Sole Proprietorships, the application shall be accomplished and signed by the owner. A representative with a notarized Special Power of Attorney (SPA) may accomplish and sign the application.

For Corporations or Partnerships, the application shall be accomplished and signed by any person duly authorized by a notarized Board or Partnership Resolution, or a Secretary's Certificate.

For a Cooperatives, the application shall be accomplished and signed by any person duly authorized by Cooperative.

- 6. List of Distributors and Retailers with their complete addresses and contact details.
- 7. Proof of ownership or contract of lease of warehouse.
- 8. Valid Certificate of Registration issued by the Bureau of Customs (BOC)
- 9. Import Entry (may be submitted after issuance by the BOC but prior to the release of the CCR).
- 10. Surety Bond. (Php 150,000.00)
- 11. Copy of the PS License issued under the name of the manufacturer and the applicant importer.
